## Conditions: -

- The enrollment of students in each class should be 50, there should be 40 attendance. The same ratio of trained teachers should be hired according to the reservation rules.
- First Recognition is provisional and permanent unaided. The salaries of the primary school staff and the maintenance of the school must be paid by the management permanently.

In elementary school, opening of other medium and additional divisions is not permitted without prior permission of the department.

The management should appoint qualified and trained teachers as per government reservation.

- The management should provide its own building, play ground and basic infrastructure.
- > Without prior permission, the management should not shift school to another location.
- ➤ The management should provide sufficient fabrication, furniture and other essential teaching aids based on the students strength.
- > Without permission of the department, management should not collect any fees.
- ➤ Without permission of the department, the management should not discontinue its teachers.
- ➤ In a school, admissions should be opened to the children belonging all caste and creed.
- The accreditation code must be renewed annually according to the grant code.
- The authority to revoke the approval and accreditation granted to the school if it does not comply with the provisions of the grant code and the directive issued by the department.

- ➤ The management should provide job security to its teachers and maintain their service register.
- As per Education act if it is lower primary school, it should deposit Rs 20,000 in the joint account of the chairman / Block Education officer as a stability Fund.
- In the name of Trust Rs 5 lack to be deposited or submitting valuvaterning document about the immovable property before one month of this grant of first recognition.

If the board of governors and the school staff hold all the above conditions, and, if the management meets all the conditions in chapter 3 of rule-9 of the code of grant and, the point here is that the next accreditation will be renewed once the grant is confirmed, the first recognition is granted as permanent unaided from 1 to 8 for English medium for the academic year 2020-21.
